Please explain your answer:

Creative Scotland is the funding, development and advocacy body for the arts, screen and creative industries. We recognise that Art, language, culture and creativity are integral to Island life. In relation to this Creative Scotland works closely and has longstanding professional relationships with many Island communities, cultural organisations, and individual artists.

Creative Scotland welcomed the introduction of the National Islands Plan. It has helped raise awareness of the Islands and in particular the unique circumstances, challenges, and opportunities that island communities face, especially in relation to accessing opportunities to participate in and attend cultural and creative activities.

The Creative Industries makes a key economic contribution to Scotland's economy, including that of the Islands. Employment in the Creative Industries growth sector stood at 78,000 in 2021. Gross Value Added for the Creative Industries growth sector was estimated at £4,440.2 million in 2021, an increase of 1.7% compared to 2020 (£4,366.4 million). In March 2022, there were 13,285 registered enterprises operating in the Creative Industries growth sector, representing 7.6% of all registered business in Scotland. We have found the National Islands Plan to be a powerful advocating tool for the Island Communities, ensuring their unique circumstances are considered when national bodies and organisations are creating new polices and services to help alleviate barriers and exclusion for island communities. In addition, it has enabled the unique circumstances of Island Communities to be better considered when projects and organisations are applying for funding.

Internally and externally for Creative Scotland, the plan has helped us advocate further for our support and development of Islands cultural and creative endeavours.

## Please explain your answer:

In a revised document it would be positive to see more focus on the empowerment and support for Community Organisations, Community Landowner Trusts, and cultural and creative organisations to carry out creative and cultural projects/initiatives within and for their own communities. Creative Scotland receives a growing number of applications from such organisations looking to carry out community and participatory arts projects.

Dualchas is a powerful Gaelic word and term which encapsulates and embodies heritage, culture, tradition, language and connection to place. More support for organisations, communities and Gaelic development officers and individual artists to creatively explore and respond to the culture would also support other strategic objectives including population retention and wellbeing.

We would recommend that Scots should be given parity with Gaelic in any plan, and both languages given due consideration in relation to the culture, heritage and creativity of all island communities. We recommend that any future plan ensures that it reflects the requirements of the upcoming Scottish Languages Bill. The Plan should also include reference to Intangible Cultural Heritage of island communities.

Cultural and Heritage Tourism would also benefit from having some further focus and encouragement for those working in this area to work in collaboration with communities, community land trusts, local cultural organisations, and island creative practitioners to ensure that culture and heritage are being represented appropriately. We believe that is important that engagement, and interactions, with the culture of island communities are of benefit to the community, and address issues of mis- representation and extractive practices.

We also consider it important that Island communities are empowered to represent, creatively explore, celebrate, and promote their culture, language, and creativity, ensuring the legacy of the culture and traditions and enabling and nurturing a contemporary culture to grow and innovate.
