



We want people to join our **advisory group**. An **advisory group** is a group of people who come together to give us advice and suggestions.




The advisory group will advise us about **Equalities, Diversity and Inclusion**, or EDI for short.

#### **Equalities, Diversity and Inclusion** means:




• Treating everyone fairly

 Making sure everyone feels welcome and included.




You might know a lot about EDI because it is your job.

Because you are married, or not married




• Because you had a baby

We also want people who understand things like:




 Money and health differences in different areas and communities

 Problems that migrants and refugees might face. Migrants and refugees are people who have come to Scotland from another country.




You do not have to work in the arts to join the advisory group. But you should be interested in the arts.

 Tell us if we are making the right decisions




Work at or run Creative Scotland

 This will happen once a year




 Helping us learn about what might make things hard for some people to make art, and how we could make it easier




 Helping us find other organisations to work with.

#### How the advisory group will work




People will join the advisory group for 3 years. This will start in February 2024.



If we choose you to join the advisory group you will need to come to a special meeting day in Glasgow.



The meeting will be on 20<sup>th</sup> February 2024.




The meeting will be from 10am until 4pm.




There will be lunch and time to rest.




The advisory group will meet 4 times a year:




There will be 3 2-hour meetings a year



And 1 half-day meeting a year.



We might ask you to come to more meetings if there is something we need to work on.



The meetings will be on weekdays.



The meetings will be **hybrid**. This means they are a mix of online and in-person.



Before each meeting, you will need to read some papers or do some other work.




We will ask about your access needs so we can give you enough time to do the work. We will also make sure meetings are accessible for you.

#### How much you will be paid



We will pay you £200 for each of the 4 meetings each year. This is for the meeting and the time it takes you to do work before the meeting.



If you need to come to an extra meeting, we will pay you another £200.




We can pay for your travel or access costs if you need us to. We can talk about this when you join the group.

#### How to apply



Send a **CV** and a **statement** to Kim Simpson. Kim is in charge of EDI at Creative Scotland.



A **CV** is a list of where you worked before and all the good things you can do.



A **statement** is like a letter telling us about you, and why you would be good for the advisory group.




In your statement you should tell us **1 or 2 important things** you want to work on in the group.




Tell us why you want to join the advisory group.




Tell us about what you are really good at and interested in.



Your statement should be short – no more than 2 pages.



Or if you record it, it should be no more than 6 minutes long.



In Part B of this document we tell you more about what you should put in your CV and statement.



You can send your CV and statement in writing, in a sound recording, or in a video


## English Gàidhlig Scots

We will look at each application to see if it is a good fit based on 3 things:




Knowing About Equal Rights:
 If you know a lot about treating everyone fairly and equally.



This is the most important thing we will look for.



Knowing about the arts in Scotland:
 If you know about art, theatre,
 cinema and crafts in Scotland.



Knowing how to solve problems:
 If you have experience solving problems and thinking up good solutions.



We will also make sure there are lots of different kinds of people on the advisory group.




We will have a meeting at 10am to 11am on Monday 22<sup>nd</sup> January 2024. You can come and find out more about the advisory group.








You must apply to join the advisory group by **12 noon on Friday 2**<sup>nd</sup> **February 2024**.



If we choose you for the advisory group, we will tell you by **Friday 9th February 2024.** 




If we choose you for the advisory group, you must come to a special meeting day in Glasgow.
